The Annual meeting was a great success. The attendees enjoyed some great food prepared by Chef Kendal Selby, BBQ ribs, risotto balls, bacon wrapped scallops and offerings of cookies and baked goods. We are not yet ready to bring back dinners before every meeting, but are considering other options to allow us to enjoy more of Chef Kendal's culinary creativity. We were able to elect a new board with the exception of a Secretary. A great thanks to the departing 2016 board members and welcome to several new board members. There was some shuffling of positions within the board for this year, new challenges for the newly elected. The three Traditional awards were presented and a few members received non-traditional recognitions.

Club member Brendan Moon provided some insight into establishing an outdoor range through a Special Exemption. He was optimistic that this could be achieved with the appropriate strategy and planning. This endeavor will need to be approached with a very coordinated and well prepared plan. There are about 12 major items that will need to be addressed before we will be able to formulate a presentable application for a special exemptions. These include physical, social, logistical and legal components to name a few. Each club member brings a different skill set and can contribute to this process. On Sunday April 23, I had the pleasure of attending the Maryland Shall Issue seminar on Wear and Carry with about 25 members of SCSC and friends. This was a very informative presentation conducted by five MSI members. There were two main parts of the seminar. Part 1: The requirements and process for applying for a Wear and Carry license which provided a summary of the application process, including required training, forms, logistics and timelines you could expect to encounter through the process. Part 2 was a summary of the legal and intellectual aspects of wear and carry laws. This was particularly enlightening as the laws pertaining to this topic are complicated and can be difficult to navigate. The take away messages from this seminar were:

1. It is possible to obtain a Wear and Carry permit in the state of Maryland, contingent upon a well prepared application. MSI is there to offer guidance and assistance.
2. The responsibility of a person possessing a W&C permit not only requires preparation for appropriate use of a firearm but also preparing yourself legally and psychologically.

One of the presenters made the statement that when you discharge your firearm in self-defense, there is a lawyer attached to that bullet, I added that there is actually at least two...or more.

Lastly, please attend the general meetings, not only does this keep you current with club business, there are plenty of old and new friends to meet and socialize with. Prior to the meeting, the Indoor range is open until 6 (in addition to regular hours the rest of the month) so take that opportunity to hone your shooting skills a bit and show up early for the meeting.

St. Charles Sportsman's Club, Inc. Membership Meeting Minutes Wednesday April 5, 2017

Representatives from the Charles County Crime Solvers organization were present. They had information available to the membership about the Blaine Lessard Memorial Trap Shoot, to be held on May 7, 2017 at the Metro Gun Club on Popular Hill Road in Waldorf. They were also selling Raffle Tickets for the choice of a Benelli Shotgun or \$750 cash. The representatives also plan to return for the May Membership Meeting. President Klein called the meeting to order at 7:05 p.m. and led the membership in the Pledge of Allegiance. Paul Goodwin offered the invocation. Board members present were Michael Klein, President; Paul Goodwin, First Vice President; Teresa Riskin, Second Vice President; Marlene Smith, Treasurer; Dave George, Property; Robert Douglas, Wildlife; Frank Fruh, Ways and Means; Jim Whitehead, Conservation and Julie Morimoto, Secretary. Fifty-three members were present.

President Klein presented an Annual Review of club activity. There is continued use of the Welcome property for hunting, several Ladies Nights were held, we continue to add new members, we had a nice picnic, marketing is increased for Middleton Hall, a lot of maintenance improvements have been made in the Hall and we have a new chef.

Special Fun Awards: Several awards were presented to members. Jose Torres was given Hero cologne for helping ladies learn how to shoot pistols. Robert Douglas was given an award of Pina Colada Mix for being present at the most Board Meetings. Tom Scheid was given a kite, suggesting that he should "go fly a kite," for being so outspoken. Pete Charney was given a Level for keeping a level head. Elaine Costello was presented with comfortable slippers so she could rest easy and put her feet up.

Second Vice President: Teresa Riskin asked Matt Noe to provide a brief summary of Junior Rifle activity. Matt reported that the kids are doing a great job. We have the NRA grant. Many thanks to Matt Noe and Michelle Klein for keeping the program going.

The Ladies Night event, held on March 23, 2017, was well-attended. Michelle Klein did a fine job planning and organizing the event. Elaine Costello and Julie Morimoto provided administrative support. Jose Torres, Michelle Klein, Mike Klein, Barry Nutwell, Ken Ptack, Dennis Thrift, Lee Wenger, Ed Winters. Manny Klein (Assistant RSO), and Jeff Riskin walked the line. At Julie's suggestion, the ladies were debriefed after they finished shooting. Michelle Klein sent a marketing email message to all attendees to inform the Ladies about all of the things that the club has to offer.

The indoor range was open for 44 hours. Sixty-one members and eleven guests used the range. The Well-Armed Woman and Ladies Night resulted in thirty-one guests, bringing in \$420 in guest fees. \$13.50 were collected in target sales. In the last twelve months, the indoor range was open 92 days, for a total of 422 hours. Members used the range 526 times and brought 197 guests.

The first Maryland Shall Issue class, which will focus on, but is not limited to, Retired Veterans, Honorably Discharged and Active Duty Military, will be held on Sunday, April 23, 2017 from 1:00 p.m. to approximately 5:30 p.m. There is no charge for the class. Conservation: Jim Whitehead announced that the subdivision at the Welcome property is still in progress. The Septic Plat was approved. The Subdivision Plat will be submitted in the next few weeks.

Treasurer: In order to provide members with the extent of Chef Kendal's culinary ability, we asked him to prepare the food for tonight's meeting. Marlene reviewed the finances for S&K. There has been a lot of progress in Middleton Hall: The Alcohol License was renewed, Cateries software will be used for inventory, Chef Kendal was brought on in October and has been providing on-site and offsite catering services, Quickbooks software, in the Cloud, is being used in the front office and we hired a cleaning company. Business is booming. Dinner events, Lunch Mixers and Food Tastings are all generating new business. Attendees are enthusiastic about the food prepared by Chef Kendal and are noticing the improvements in the facility. The finances for SCSC were reviewed. Finance reports for S&K and SCSC were made available to members. Please contact Marlene with any questions.

Members extended their thanks to Marlene for all of her hard work this year which resulted in increased sales at the hall.

Secretary: Julie Morimoto made a motion to approve the minutes of the March 1, 2017 Membership Meeting as printed in the Recoil. Jim Whitehead seconded the motion and the motion was approved. Teresa Riskin asked that the Good and Welfare minutes be modified to reflect Frank Fruh's opinion that the use of monthly allowances should be for range maintenance, not range improvements.

Election of Board of Directors:

Chairman and conducted the proceedings. Members were asked to vote whether they wanted to vote by Ballot or by Standing. It should be noted that the Standing vote requires members to Stand to vote in favor of and to Stand to vote not in favor of. Members voted for a Standing vote.

Nominations were called for the office of President. Michael Klein was previously nominated. Michelle Klein was nominated and declined. There being no further nominees, a motion was made, seconded and passed to close the nominations. President Klein instructed the secretary to cast a majority ballot for Michael Klein as President.

Nominations were called for the office of First Vice President. Paul Goodwin was previously nominated. Frank Fruh was nominated and accepted. There being no further nominees, a motion was made, seconded and passed to close the nominations. A standing vote took place and Paul Goodwin was elected First Vice President.

Nominations were called for the office of Second Vice President. Robert Douglas was nominated and accepted. There being no further nominees, a motion was made, seconded and passed to close the nominations. President Klein instructed the secretary to cast a majority ballot for Robert Douglas as Second Vice President.

Nominations were called for the office of Secretary. Jake Thomas asked the membership to thank Julie for the good job that she did as the Secretary. Elaine Costello was nominated and declined. There were no nominations.

Nominations were called for the office of Treasurer. Marlene Smith was previously nominated. There being no further nominees, a motion was made, seconded and passed to close the nominations. President Klein instructed the secretary to cast a majority ballot for Marlene Smith as Treasurer.

Nominations were called for the office of Publicity Director. Frank Fruh was previously nominated. There being no further nominees, a motion was made, seconded and passed to close the nominations. President Klein instructed the secretary to cast a majority ballot for Frank Fruh as Publicity Director.

Nominations were called for the office of Ways & Means Director. Julie Morimoto was nominated and accepted. There being no further nominees, a motion was made, seconded and passed to close the nominations. President Klein instructed the secretary to cast a majority ballot for Julie Morimoto as Ways and Means Director.

Nominations were called for the office of Huntsmaster. Jarrell Reeder was previously nominated. Clay Starner was nominated and accepted. There being no further nominees, a motion was made, seconded and passed to close the nominations. A standing vote took place and President Klein instructed the secretary to cast a majority ballot for Clay Starner as Huntsmaster.

Nominations were called for the three Directors at Large. Dave George and Jim Whitehead were previously nominated. James Stanton was nominated and accepted. There being no further nominees, a motion was made, seconded and passed to close the nominations. A standing vote took place and President Klein instructed the secretary to cast a majority ballot for David George, Jim Whitehead and James Stanton as Directors at Large.

Dave Smith reminded members that a Special Meeting will need to take place next month for the open positions on the Board. Members thanked Dave for serving as the Nominating Committee Chairman.

Regarding the Welcome property, Brendan Moon gave a presentation on Charles County Government Special Exception hearings. Brendon is Chairman on the Charles County Zoning Board and is also a member of the club. He would have to recuse himself from voting on our Special Exception hearing. Jim Whitehead volunteered to help us with the engineering to get the Special Exception. Brendan stated that a meeting of club members was held to discuss the Safe Shooting area at the Welcome Property. He let the membership know that in order to get the Special Exception, we need to meet legal standards and public perception, with the key being Safety. Brendan encouraged members to be involved, to attend the hearing and participate if only to say that you support the Special Exception. We need to talk positively about the Sportsman's Club. We need to compare ourselves to ranges that are being run properly. He is willing to talk to members about the Special Exception process. In terms of property values, we need to consider the impact from traffic and noise. Dave George suggested that the biggest complaint will be about the noise-level.

Awards

Marlene Smith and Michelle Klein were nominated for Member of the Year. The ballot votes were counted and Marlene Smith was presented with the Member of the Year award. Teresa Riskin was named the Chairman of the Year. Junior Rifle Committee, chaired by Matt Noe, was named the Committee of the Year. Jeff Riskin was named the Key Member of the Year. Property: Dave George announced that work needs to be done at the Welcome Property. The barn roof needs to be secured. The beavers have been busy at the Dam. A member suggested calling DNR to have the beavers removed.

Membership: Eric Hitch, Larry and Sally Carpenter and Kenneth Shaw were presented as new members. Robert Douglas made a motion to accept the new members. The motion was seconded, all members present voted in favor and the motion was approved.

Door Prizes: Young Mr. Douglas started the ball rolling on door prizes. Almost everyone in attendance won something.

Good and Welfare

The Friends of the NRA dinner is coming up and a notice was included in the Recoil. Synopsis of the Minutes of the Board Meeting Wednesday, April 19, 2017

- The meeting convened at approximately 8:15 PM, All newly elected board members were in attendance with the exception of the unfilled Secretary position.
- March Minutes were Approved

- Marlene Smith provided a financial report and status update on critical business aspects of the club including submission of tax documents and outstanding debts.
- First VP Paul Goodwin provided an update on the plans to finish a floor in the barn at the Welcome property. Also his enthusiastic support for moving forward with the development of the Special Exemption for the outdoor range.
- Second VP Robert Douglas reported The Indoor range committee had requested support for an updated target system. Mike and Paul will follow up on funding from outside sources. Robert and Paul have repaired the roof tin of the barn at the Welcome property and removed a large tree branch overhanging the barn. Robert has surveyed the Cool Spring Lake dam with member Rocky and they are formulating a plan to mitigate the eroding spillway.
- Huntsmaster Clay Starner provided a report on turkey hunting and indicated that members should be aware of other hunters while on the Welcome property, providing each other as wide a buffer as reasonably possible We may need to reevaluate a zone system to avoid unintentional intrusion while members are hunting.
- Conservation Director Jim Whitehead reported that the subdivision process for the Welcome lots is well underway but will still take several additional months to go through the county approval process. Jim provided some ideas on responding to the stop work order on the berms at the Welcome property. There was some discussion regarding shooting in the Welcome property area which is most likely from the nearby church.
- Property Director/Membership Chair, Dave George, reported that beavers were impacting the Cool Spring Lake Dam. Mike has obtained a nuisance animal removal permit. No new member applications were received. A summary of current membership numbers was provided.
- Old Business
Maryland Shall Issue will be conducting a Wear and Carry Seminar Sunday April 23
Frank Fruh, as Publicity Director, will be contacting nearby ranges and gun clubs to work on collaborative efforts and social events.
James Staton, as Conservation Director, will be developing a wildlife enhancement plan for the Welcome property.
- New Business
Julie Morimoto provided a summary of non-substantive SCSC By-Law updates to be issued in the May Recoil and incorporated into the By-Laws
Marlene provided a report on the costs of the Annual meeting and a discussion followed regarding selling meals prior to the meetings.

With Spring Turkey Season in full swing and running until 23 May, please remember that Safety is paramount While hunting our Welcome property (and anywhere you hunt for that matter), be courteous of other hunters and cognizant of their location. Hunting on the Welcome property is on a first come, first served basis. When you sign in to hunt the property and there are others signed in, be mindful of where they may be hunting. If there is a vehicle parked near an area you plan to hunt, do your best not to disturb another hunter and travel to another location on the property to hunt. This applies to all hunting seasons, but is especially essential when Spring Turkey hunting. Remember: A Safe Hunt is a Successful Hunt!

On a separate note: If there are any members that Trap, the Club was issued a Maryland Department of Natural Resources Permit to Control Nuisance Wildlife to control the Beaver population on the Welcome property by means of Conibear, Foothold or Cage Traps. This permit is valid until 06/06/2017. For further information, please contact me or Dave George
