Included is a copy of the '2015 Hunting Lottery.' Eleven (11) days have been identified (highlighted – first day is Sat 24M – Muzzleloader season) as heavily requested days to hunt the property. The form allows a maximum of two (2) hunters to request a maximum of three (3) days during the hunting season. Forms must be submitted along with a self-addressed envelope by the Sept 19th deadline. Applications should be addressed to: Lottery Application, 4045 Renner Road, Waldorf, MD 20602. Those selected will be notified via mail and their names entered on the "SCSC - Hunters Selected by Lottery" form. This form will be published in the Recoil and the SCSC website. Days not selected will be on a first-come basis. A sign-in sheet will be made available in the small shed next to the barn. Please sign-in and note on the map the area you will be hunting, please sign-out when leaving for the day. We'll see how hunting goes this fall and make any needed adjustments for the spring turkey season. Please report all game taken to the Huntsmaster and be safe and respect other hunters!

Annual Membership Meeting Minutes
Wednesday August 5, 2015

President Klein called the meeting to order at 8:05 p.m. The membership recited the Pledge of Allegiance. Jake Thomas offered the invocation. Board members present were Mike Klein, President; Paul Goodwin, First Vice President; Teresa Riskin, Second Vice President; Elaine Costello, Secretary; Marlene Smith, Treasurer; Tony Malpasso, Huntsmaster; and Robbie Schroeder, Conservation. Absent were Bill Davis, Publicity; Dave George Property and David Hough, Wildlife. Forty-two members and guests were present, 33 signed the roster.

President: Mike Klein welcomed members to the meeting.

Treasurer: Marlene Smith gave the treasurer's report. She invited members to contact her if they needed further information.

Second Vice President: Teresa Riskin reported the indoor range is in need of additional RSOs. We currently have three volunteers who work all the open hours. Frank Fruh has been added to the roster of working RSOs. If you want to be put in the rotation and are RSO trained, please let Teresa know or any committee member. If you have trained with us and haven't been down there, please consider volunteering. We may be able to keep the range open longer or even open another day. This is our one place to shoot our handguns. An RSO meeting will be held soon.

Secretary: Elaine Costello made a motion to approve the minutes of the July 1, 2015 membership meeting as printed in the Recoil. After a second, a correction was made to the reference to coffee at the indoor range. It is \$1 a cup, not free. Also, the contact for Ladies Night is Jose Torres, not the indoor range phone number. Corrections will be made on the club website. The vote to accept the minutes as corrected was called and the motion passed.

President: Mike Klein reported that Pat McGinnis has resigned his position of Ways and Means Director. We will open nominations to fill this position later in the meeting.

Huntsmaster: Tony Malpasso reported that the hunting parking permit will be distributed to the membership in the September Recoil. Additional properties have been added to the list of designated public lands open for Sunday hunting. The 2015 General Assembly repealed the extended firearms deer season previously offered in Charles and St. Mary's Counties. These counties will now follow the regular firearms deer season dates. He recently visited the Mt. Jackson property. The road to our property and the building are intact. There is no erosion on the hillside or road. The access road to the property has been repaved to the top of the mountain.

Wildlife: President Klein reported he recently returned from a trip to Alaska to celebrate his 50th birthday. He spent three days in Pelican, Alaska, halibut and salmon fishing at Highliner Lodge.

Membership: President Klein reported there were no new membership applications in July. Ed Jordan donated a shed to the club and it has been placed at the Welcome property. Thank you, Ed.

Indoor Range: Ken Ptack reported 7 RSOs worked 77 hours last month. There were 39 members who shot at the range as well as 11 guests. We collected \$110 in guest fees and \$6.60 in targets fees.

Frank Fruh made a suggestion that we post at least two phone numbers as contact for Ladies Night since Jose is on vacation.

Land Development: Paul Goodwin reported we have a safe shooting area to build. We have a suitable location and we need to get volunteers

to build it. We need younger members to step up. Now that we have property, we can attract these young shooters. We need a single axle dump truck to haul gravel from other areas of the property to improve the road to the shooting area. We also need a bucket truck with a front loader and a blade to grade the road. If you know of anyone who has access to this equipment, please let Paul know. We can trench and provide silt control. When we built the old range, we did it with volunteers and no out-of-pocket costs. We have a little area we need to clear of small trees and brush. The concrete has been donated for the floor in the barn and a volunteer has offered to lay the cement. Once we get that done we can secure the barn for storage and other things. We are on a limited budget so donations and volunteers are necessary. We need to start thinking about our future as a club and attracting younger shooters, hunters and sportsmen. Be on the lookout for the equipment we need and pass the information on to Paul. A member stated we have members who own this type of equipment and suggested that we put a notice in the Recoil stating our needs. A discussion followed regarding the safety of no blue sky ranges. We will investigate the NRA reports. A schedule will be created showing work days at the Welcome Property so members will know when they are needed. President Klein asked if members know of available equipment, please call them directly or notify the president and he will call them.

Marlene Smith reported a forestry plan has been developed and will be submitted to maintain the agricultural tax status on the Welcome property.

Junior Rifle: Perrin Lewis reported that Junior Rifle meets the first Sunday of each month. Last week we had two kids show up due to the summer slowdown. If you want to check or improve your shooting skills, think about taking part in the Appleseed event. Perrin is available for individual assistance. The Appleseed match will take place at the indoor range on August 22 and 23. Registration is open to the public. More information is available at appleseedinfo.org, select the Waldorf location.

President Klein reminded members of our Annual Family Day picnic scheduled for Sunday, September 13 at our Welcome property. This is a good opportunity for you to see the property and scout for hunting season. There are plenty of deer. We will provide port-a-potties and are working on what the club can provide. There is a sign-up link in the Recoil. If you don't have a computer, please call the president.

We have a few committees that need a chairman, Legislative, Bylaws and Hunter Safety. If you are interested in serving, please let me know.

Special Election

President Klein opened nominations to fill the vacant position of Ways and Means Director. No nominations were forthcoming. Nominations will remain open until the special election at the September membership meeting. A notice calling for nominations will be published in the September Recoil.

Old Business

Marlene Smith reported that we are working with counsel on the pending lawsuit. Work has been endless. Depositions are being taken now. Our court date is set for October.

President Klein opened the floor for discussion on the new Hunting SOP as printed in the August Recoil. This policy will stand for the coming season and will be revisited if there are any issues. Brian Rehm made a motion to accept the policy as printed in the Recoil. After a second, the vote was called and the motion passed. Tony Malpasso explained how the hunting lottery will work. Discussion followed clarifying the policy.

New Business

A member asked if we could consider opening the meetings earlier than 8 p.m. He suggested a survey in the Recoil asking members for their opinions. A survey will be included in the September issue.

Good and Welfare

Brian Rehm turned in a check for \$150 donated by Mrs. John Lane in honor of her husband, a member who passed away. The donation was from sales of reloading equipment which Brian is selling for her. If you need reloading supplies, please call Brian to see what is available.

Brian Rehm also announced the upcoming hunter education class on September 8, 9, 10, and 12 at the Jay Cees hall. Registration is available on line.

Paul Goodwin announced that member, Jim Stewart, who owns a catering business, is willing to provide food at the membership meetings at cost. He suggested each member pay \$10 with half coming back to the club. The board will discuss the offer.

President Klein reminded members that door prizes are being offered at the meetings. This month's prizes are a bag of freshly dug potatoes from Mike's farm, a camo teddy bear and a pack of exploding targets. The bear was won by Steve Haimbach, Lee Wenger won the targets, and Dennis Sullivan won the potatoes.

The 50/50 was drawn and the winner of \$15 was Lee Wenger. Bob Baggstrom won the workers drawing for indoor range work.
